### ASSIGNMENT

WHEREAS, pursuant to the Declaration of Covenants, Conditions and Restrictions and Abandonment of Real Property (the "Declaration") recorded in O.R. Book 5042 at Page 1258 of the public records of Escambia County, Florida, the Association was to act as Conservation Manager as defined in the Declaration; and

WHEREAS, the Association was administratively dissolved September 28, 2012 for failure to file its annual report and desires to wind up its business; and

WHEREAS, Indigo Condominium Association, Inc. ("Indigo"), a Florida not-for-profit corporation is the successor Owner of the property described in the Declaration pursuant to the Quitclaim Deed recorded in O.R. Book 8000 at Page 241 of the public records of Escambia County, Florida; and

WHEREAS, the Association desires to assign its duties as Conservation Manager as outlined in the Declaration and Indigo desires to designate a Conservation Manager to perform the duties set forth in the Declaration; and

WHEREAS, Glen A. Miley was a Director of the Association.

NOW, THEREFORE, for good and valuable consideration and the promises contained in this Assignment, Glen A. Miley desires to assign the Association's duties to Indigo and Indigo desires to fulfill those duties under the Declaration, and agree as follows:

1. The recitals are correct and adopted by reference.
2. Glen A. Miley assigns the rights, duties and responsibilities of the Association as Conservation Manager to Indigo and declares that the Association has no further rights, duties, or responsibilities under the Declaration as of the date this Assignment is recorded in the public records of Escambia County, Florida.
3. Indigo shall have all rights, duties and responsibilities of the Conservation Manager as set forth in the Declaration and warrants it will fulfill the requirements in the Declaration as of the date this Assignment is recorded in the public records of Escambia County, Florida.

4. The Effective Date of the Assignment is the date the Assignment is recorded in the public records of Escambia County, Florida.

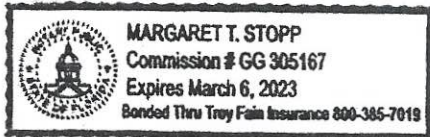

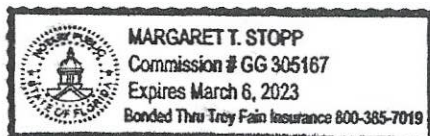
